Migration, right or plight?

Deeper into the Greek crisis

Central issue: *The Union and its Member States are faced with sharp dilemmas between what they claim to be and what they are forced to be in a mirror reflection with the outer world. Migratory fluxes from a faltering Arabic world urge them to crucial identifications as to what it means to have fundamental differences with neighbors. Torn apart by warfare kindled by economic and religious implosion, the Middle East and Northern Africa generate strongly diversified massive migration towards the European Union, unequally targeted as to its member states. Social unrest from economic recession and freezing effects from religious terrorism draw Europe back to what historically shaped it in terms of opposition to her neighbors. Demographics, economy, humanitarianism and social cohesion interweave in producing difficult public choices before visible dismantling effects on the fragile European structures, both at the Union level (Schengen zone) and the Member States level (selecting and guesting migrants).*

What is the impact of the distinction between a refugee and an economic migrant? Where does the menace end and the advantage begin in hosting migrants? What values are at stake in terms of tolerance?

INSTRUCTIONS TO AUTHORS

1. Submission of texts

All manuscripts must be submitted in Word format as an email attachment. Communications concerning the submission of manuscripts should be sent to Mr Ioannis Mournianakis (europeanpoliteia@eplo.eu). Manuscripts to be submitted for consideration should be in one of the three most widely spoken European languages: English, French or German.

Articles should preferably be no longer than 4.000-5.000 words, including footnotes, and should be submitted together with an abstract of 100-150 words in length. If the article is written in a language other than English, then an abstract and title in English should be submitted as well. Notes should be numbered sequentially in superscript in the text outside punctuation marks and placed as footnotes included in the main text (after an initial unnumbered note attached to the author's name by an asterisk, stating his/her professional capacity).

Case notes or *legislation notes* should not exceed 2.500 words.

Book Reviews should not exceed 1.500 words and have no footnotes.

2. Headings - Style

In articles, case notes or legislation notes, individual paragraphs should not be numbered. Subdivisions with headings are preferred and a maximum of four levels of heading is suggested, as set forth below:

Article title

I. Section

A. Subsection

1. Paragraph

Phrases in capitals or underlined text should be avoided.
