Subject: *Invitation to scientific conference*

Dear Professor,

The Faculty of Law of the University of East Sarajevo is pleased to invite you to attend the **XV Scientific conference on the occasion of the Day of the Faculty of Law, on the comprehensive theme "Law Between Truth and Certainty"**, which will be held on **24. October 2026** in Pale. Co-organizers of the scientific conference are the European Public Law Organization, International Union of Lawyers and Institute for Comparative Law. This year, we are holding the conference on the occasion of the **80th anniversary of the Faculty of Law**.

Scientific conference on the occasion of the Day of the Faculty of Law has been classified as an international conference of particular significance within the first category by the Ministry of Scientific and Technological Development and Higher Education of the Republic of Srpska. Our scientific conference is among the top three conferences in the country in all legal fields and the first one in social sciences and humanities. At the XIV Scientific Conference, held at the end of October 2025, **240 authors and co-authors from 36 countries across five continents participated** (Greece, Russia, Hungary, Nigeria, Turkey, Italy, Cyprus, Malaysia, Portugal, Oman, Romania, Poland, Vietnam, Slovakia, Bulgaria, Netherlands, Spain, United Arab Emirates, Switzerland, Mexico, Moldova, Peru, Algeria, Canada, South Africa, England and Wales, Sri Lanka, Kyrgyzstan, Norway, Georgia, Morocco, Serbia, Croatia, Montenegro, North Macedonia, Bosnia and Herzegovina – Republic of Srpska and the Federation of Bosnia and Herzegovina), who presented **179 papers** in Serbian, Russian, English, Italian, or the native language of the participant.

The conference theme is broad enough to allow participants to choose their specific topic. As usual, the work will be organized in breakout sections: Public Law Section (Theory of State and Law, Constitutional Law, International Law, Administrative Law and Labour Law), Civil Law and Corporate Law Section, Criminal Law Section, Section for the Roman Law and the Legal History, and Tax Law Section.

We intend to organize the conference in a **hybrid model**, primarily on-site, but with the possibility of some participants, mainly but not exclusively from distant countries, participating online using the Zoom platform.

Please submit **your application with the title and abstract** of your report (up to one-half of the A4 page) and **keywords** no later than **10 October 2026** to konferencijapale@pravni.ues.rs.ba

Accommodation and meals for two days will be provided by the Faculty of Law. Unfortunately, the Faculty will not be able to cover the participants' travel expenses.

Reports will be presented at the conference and subsequently published in the conference proceedings. **The deadline for submitting the papers is 30 April 2027**. Conference proceedings will be included in the following bases of journals and e-books: *HeinOnline*, *EBSCO OPEN ACCESS* and *Central and Eastern European Online Library (CEEOL)*.

We sincerely hope that you will accept our invitation and contribute significantly to the success of our conference.
